

Good Fellos \$25 Gift Certificate Give-Away Rules:

No purchase necessary. Void where prohibited. All federal, state and local regulations apply.

Contest Dates: March 7, 2022, and ending May 27, 2022, at 5pm

You must be 21 years of age or older at time of entry to be eligible for this contest. This contest is void where prohibited by law.

Winners will be notified by email and or telephone. If a winner is unreachable after seven (7) days, or if that winner is unavailable for prize fulfillment, an alternate winner will be selected. If an eligible winner cannot be found for the prize, that prize will not be awarded.

WWNY reserves the right to restrict the local winners to only persons whose primary residence is within a 60-mile radius of 120 Arcade Street Watertown, NY 13601.
